

Notice to Boat Owners

The boat launch ramp is provided as a service to boat owners. Its use is at the express risk of the user, and neither the Fallen Leaf Lake Community Services District, its directors and agents, and each of them, nor CLM Services, nor the marina manager shall be responsible for injury or damage to boats or their owners or agents arising out of or in any way connected to the launching, removal from the lake, or any other use whatsoever of the ramp itself, or of vehicles using the ramp (including but not limited to boats and/or other watercraft, vehicles including automobiles, trailers, and any other devices of any sort used as a part of the launch or pull out process).

The person (hereafter Signatory) whose signature appears below acknowledges that he or she is the owner or authorized agent of the owner of the vessel being launched or pulled out as well as of the vehicle and/or other device intended to be used to undertake the launch or pull out process. Signatory further acknowledges that he or she has read this Notice in full and agrees to be bound by and to abide by its terms. Signatory further agrees to indemnify and hold harmless the Fallen Leaf Lake Community Services District, its directors and each of them, its agents and the store and marina concessionaire, (CLM Services and marina manager if different), and each of them, from and against any and all claims presented by anyone and arising out of the use by Signatory and/or its agents of the ramp as well as roads and other access ways used by Signatory and/or its agents in connection with the launch and pull out process.

Signatory further understands and agrees to be bound by the following terms and conditions applicable to use by the public (which term includes but is not limited to Fallen Leaf Lake homeowners, their family members, renters, cabin users, equipment and service providers, and any and all other persons acting for their benefit or at their invitation as well as members of the general public) (hereafter "Users") of the launch ramp:

1. The boat launch ramp is open during business hours between the dates publicized by the marina manager (typically May 31st

and September 30th of each year) (hereafter the Season). It is not to be used by members of the public, including Users outside of those dates other than by permission specifically provided on a case by case basis by an authorized representative of the Fallen Leaf Lake Community Services District and/or of CLM or its successors or assigns.

2. Notwithstanding the foregoing, under no circumstances shall the boat or watercraft being launched be left in the lake after November 1st of each year or be launched prior to May 1st.
3. Neither the Fallen Leaf Community Services District nor the Marina Concessionaire (CLM Services), or either of them or its owners or directors shall be responsible for loss or damage to the vessel being launched or to any person or persons owning or using said vessel and caused by storms, wave action, lake level changes, or any other reason whatsoever whether during the season or at any other time when the vessel may be in the lake.
